

Dear Mr. & Ms. Freeman:

This letter is to inform you of a several state and municipal code violations that exist on the above referenced property owned by you. These violations relate to the installation and operation of "coffee shop, gift shop, and art gallery" without the plan approval, issuance of permits and 'Certificate of Occupancy' required by the following codes:

Banning Municipal Code Sec. 15.12.010 - Permits Required

Banning Municipal Code Sec. 15.12.020 – Application and Plans Required

Banning Municipal Code Sec. 15.12.030 – Fees Required

California Building Code Sec. 105.1 – Permits Required

California Building Code Sec. 105.3 – Application for Permit Required

California Building Code Sec. 106.1 - Submission of Construction Documents Required

California Building Code Sec. 108.1 – Payment of Fees Required

California Building Code Sec. 101.1 – Certificate of Occupancy Required

The business proprietor, Mr. Vince Pellegrini, has been verbally notified, several times, of the need to comply with the above requirements and in writing in the form of a correction notice dated 12-1-09, a copy of which is attached. To date Mr. Pellegrini has submitted partial plans for the improvements without the required application or payment of fees. Hence this submission is deemed incomplete and this matter remains unresolved.

Violation of the above referenced code sections constitute a violation of Banning Municipal Code Sections 8.48.020 and 8.48.080 which make the matter of "Public Nuisance. Before I initiate a code enforcement case in pursuit of resolution of this matter, which carries with it costs that are the responsibility of the property owner, I want to give you the opportunity to investigate resolution options.

I will withhold further action in this matter for a period of ten days from the date of this letter. If the appropriate application, documents and fees are not received within that time then I will have to proceed with an enforcement action which may include costs to you, interruption of the business and an "ORDER TO VACATE" the building.

Your cooperation in the resolution of this matter is appreciated.
