1 NOW, THEREFORE, by reason of the law, IT IS ORDERED, ADJUDGED AND
2 DECREED:

3 1. There is due, owing and unpaid to plaintiff, Delton J. Dysart, from defendant Jim
4 Smith, as alleged and set forth in plaintiff's complaint, the principal sum of \$100,305.29, with
5 interest thereon at the rate of 10% per annum from April 30, 2010 through and including May 11,
6 2012, in the amount of \$21,517.55, plus costs incurred herein for filing the complaint and service of
7 process of summons in the amount of \$444.20, for a total of \$122,267.04.

8 2. That default judgment is hereby entered in favor of plaintiff, Delton J. Dysart, and
9 against defendant Jim Smith in the principal amount of \$100,305.29, with interest thereon at the rate
10 10% per annum from April 30, 2010 through and including May 11, 2012, in the amount of
11 \$21,517.55, plus costs incurred herein for filing the complaint and service of process of summons in
12 the amount of \$444.20, for a total of \$122,267.04, ~~with interest continuing to accrue at the rate of~~
